PETITION FOR A WRIT OF MANDAMUS

This is an action to enforce Wis. Stat. §§ 60.12(3) and 60.33(6)(b). Petitioner Brenda Dettloff and other concerned citizens of the Town of Hayward have filed three written requests with Respondent Bryn Hand, the Clerk/Treasurer of the Town of Hayward, to convene a special town meeting, yet Respondent has repeatedly refused to notice the meeting, even though the requests satisfied all statutory requirements. They filed their third request on August 18, seeking a special meeting on September 15, yet Respondent again denied the request. Petitioner, by her undersigned attorneys, hereby applies to this Court for a writ of mandamus ordering Respondent, in her official capacity as Clerk/Treasurer of the Town of Hayward, to notice the meeting, as required by Wis. Stat. § 60.12(3). Petitioner alleges: 1. Petitioner is a citizen who resides at 15838W Kadlec Road, Hayward WI 54843.

2. Respondent is the Clerk/Treasurer of the Town of Hayward.

Respondent maintains an office at 15460W State Board 77E, Hayward,
 WI 54843.

4. Respondent also receives mail at that address.

5. This Court has jurisdiction to hear and decide this petition pursuant to Article VII, Section 8 of the Wisconsin Constitution and Wis. Stat. chs. 60 and 783.

6. Venue is proper in Sawyer County under Wis. Stat. § 801.50(2)(a) because "the claim arose" in Sawyer County.

7. Venue is also proper in Sawyer County under Wis. Stat. § 801.50(2)(c) because Respondent "does substantial business" in Sawyer County.

8. On April 18, 2023, Hayward held an annual town meeting.

9. At the annual town meeting, three resolutions were adopted.

10. Resolution No. 04-2023A purportedly "authorize[d] the Town Board of the Town of Hayward to construct a new services & governance complex at maximum cost of \$15,000.000.00 [sic], pursuant to 60.10(2)(f) of the Wisconsin Statutes."¹

11. A true and correct copy of Resolution No. 04-2023A is attached hereto as Exhibit A.

¹ Given the placements of the periods, Resolution No. 04-2023A appears to have authorized a maximum cost of only \$15,000. Hayward officials have treated the resolution as if a scrivener's error occurred and the resolution authorized a maximum cost of \$15,000,000.

12. Resolution No. 04-2023B purportedly "authorize[d] the Town Board of the Town of Hayward to increase the size of the Town Board from 3 to 5 members consisting of 1 chair and 4 supervisors pursuant to section 60.21(2) and 60.10(2)(b) of the Wisconsin Statutes."

13. A true and correct copy of Resolution No. 04-2023B is attached hereto as Exhibit B.

14. Resolution No. 04-2023C purportedly "authorize[d] the Town Board of the Town of Hayward to reorganize the separate Clerk & Treasurer positions so far as to form a position of combined Clerk/Treasurer and a position of Deputy Clerk/Treasurer, pursuant to Section 60.305(1) of Wisconsin Statutes."

15. A true and correct copy of Resolution No. 04-2023C is attached hereto as Exhibit C.

16. Petitioner and other concerned Hayward citizens have filed three written requests with Respondent to hold a special town meeting to have the aforementioned resolutions reconsidered, which is their statutory right under Wis. Stat. § 60.12(1)(b) (2021–22).

17. True and correct copies of the written requests are attached hereto as Exhibits D, E, and F.

18. Pursuant to Wis. Stat. § 60.12(1)(b), a written request needs to be "signed by a number of electors equal to not less than 10 percent of the votes cast in the town for governor at the last general election"

19. In the last such election, Hayward citizens cast 1,642 votes. See https://www.sawyercountygov.org/ArchiveCenter/ViewFile/Item/539.

20. Accordingly, each written request needed to be signed by no fewer than165 Hayward citizens.

21. Each written request was signed by over 200 Hayward citizens.

22. In fact, the most recent written request was signed by over 270 Hayward citizens.

23. Each written request stated "the time, date, and purpose" of the special town meeting, as required by Wis. Stat. § 60.12(2).

24. Each written request also stated the location of the special town meeting. Wis. Stat. § 60.12(3).

25. Each written request also stated that Hayward citizens at the special town meeting would reconsider the three aforementioned resolutions, as required by Wis. Stat. § 60.14(4)(b).

26. Therefore, each written request satisfied all statutory requirements.

27. Neither Respondent nor any other Hayward officer has discretion to deny a written request that meets all statutory requirements.

28. In an email dated August 21, 2023, Respondent acknowledged, "[t]he town of Hayward does <u>NOT</u> have the authority to deny a request based on any other reason than it not meeting the statutory requirements."

29. A true and correct copy of that August 21, 2023 email is attached hereto as Exhibit G.

30. Each written request was unlawfully denied.

31. The most recent written request was provided to Respondent on or about August 18, 2023.

32. The most recent written request provided a time, "6:00 p.m.," and a date, "September 15, 2023," for the special town meeting.

33. The most recent written request also described what the purpose of the special town meeting would be in detail.

34. Specifically, and similar to the prior requests, the most recent written request explained that the purpose would be to "Reconsider and Rescind the actions taken in the adoption of the following Resolutions," and then listed resolutions 04-2023A, 04-2023B, and 04-2023C, which are described in paragraphs 10–15 above.

35. The special meeting request separately listed, as its purpose, to:

Reconsider and Rescind all previous Resolution actions taken pertaining to directives and/or continuing grants of authority bestowed onto the Town of Hayward Board by the electors under WI Stat. 60.10(1) Direct Powers; 60.10(2) Directives or Grants of Authority to Town Board; and 60.10(3) Authorization to the Town Board to Appropriate Money; to include all authority under each subsection with the exception of authority which is conferred on the Town of Hayward Board by Wisconsin law.

36. On or about August 18, 2023, Respondent unlawfully denied the most recent written request.

37. A true and correct copy of Respondent's August 18, 2023 denial is attached hereto as Exhibit H.

38. In Respondent's denial, Respondent first asserted that a cover letter attached to the most recent written request somehow invalidated the request because

"the cover letter of the written request and the language of the petition itself are inconsistent with one another."

39. Respondent did not expound on this first point further.

40. Second, Respondent claimed, "some of the purposes enumerated cause the request itself to be defective."

41. Respondent did not expound on this second point further.

42. A cover letter is not required to be attached to a written request by any Wisconsin Statute.

43. None of the more than 270 signatures appear on the cover letter attached to the most recent written request.

44. Any differences between language in the cover letter and the most recent written request are therefore irrelevant.

45. Furthermore, the differences in language are non-substantive and trivial.

46. Additionally, none of the purposes enumerated in the most recent written request render the request defective.

47. Wisconsin Stat. § 60.12(5) provides that "[a]ny business which may be transacted at an annual meeting may be transacted at a special town meeting."

48. Also, Wis. Stat. § 60.14(4)(b) presupposes that a special town meeting may be convened to "reconsider[]" the "action[s]" of a town meeting.

49. Because the most recent written request satisfied all statutory requirements—as did the first two written requests—Respondent, for a third time,

violated her plain legal duty when she refused to notice the September 15, 2023 special town meeting.

50. Specifically, Wis. Stat. § 60.12(3) provides:

The town clerk shall, not more than 20 nor less than 15 days before the date of a special town meeting, publish a class 2 notice of the meeting under ch. 985. The notice shall state the purpose, date, time and location of the meeting. If notice is posted, the same time and content requirements apply.

51. Similarly, Wis. Stat. § 60.33(6)(b), which is titled "**Duties of town clerk**," also provides that a "town clerk shall: . . . Give notice of annual and special town meetings as required under ss. 60.11(5) and 60.12(3)."

52. Respondent violated both Wis. Stat. §§ 60.12(3) and 60.33(6)(b).

RELIEF REQUESTED

WHEREFORE, Petitioner demands a writ of mandamus to issue against

Respondent:

- 1. Compelling Respondent to immediately notice the special town meeting;
- 2. Awarding Petitioner damages and costs under Wis. Stat. § 783.04; and
- 3. Awarding such other relief as the Court deems appropriate.

The Town of Hayward has consulted with Weld Riley Law Firm to review the petition submitted by Town citizens on August 18, 2023, which was requesting a Special Town Meeting pursuant to Wis. Stat 60.12(1)(b) to reconsider and rescind various Resolutions previously passed by the Town (to be held September 15, 2023 at 6:00pm).

The conclusion is that the request should be denied as defective for the following reasons:

First, the cover letter of the written request and the language of the petition itself are inconsistent with one another.

Second, some of the purposes enumerated cause the request itself to be defective.

It is therefore concluded that the request for a special meeting is denied as defective because the stated purposes of the meeting are not sufficiently clear for proper notice or action by the public.
